**CELA is a non-profit organization that provides accessible books for free through Canadian public libraries.**

## Who qualifies for the CELA Program?

Anyone who is print disabled because of blindness, visual impairment, physical disability and/or learning disability in accordance with the definition provided for “perceptual disability” in Section 32. (1) of the Canadian Copyright Act qualifies.

“Perceptual Disability” means a disability that prevents or inhibits a person from reading or hearing a literary, musical, dramatic or artistic work in its original format, and includes such a disability resulting from:

- 1) Severe or total impairment of sight or hearing or the inability to focus or move one's eyes.
- 2) The inability to hold or manipulate a book.
- 3) An impairment relating to comprehension.

Libraries will need to ensure that access to the CELA Program is provided only to patrons who have a perceptual disability.
